ANTI-TRUST STATEMENT

The RCMA is pleased to convene this meeting for providers who are affected by the IEHP contract termination with Vantage IPA.

Many of you in the room and on the phone may be direct competitors. Because the exchange of some information among physicians, who are not in a risk-sharing arrangement, are subject to strict scrutiny under both federal and state antitrust laws, RCMA, IEHP and the participants at this meeting must proceed cautiously to ensure compliance with such laws.

Therefore, at no time during this meeting or any other meeting of physicians who are not in a risk-sharing arrangement, is it appropriate for physicians to:

- Discuss reimbursement rates paid by IPAs, IEHP or other payors to their participating providers;
- Discuss prices charged by physicians to their customers
- ▶ Discuss mutually agreed upon limitations on the services offered by physicians, regardless of whether those limitations are defined by product, geography, customer segment, or any combination thereof; and
- Discuss mutually agreed upon refusals to conduct business with specific health care providers, groups of providers, or other individuals or groups who may or may not provide services to physicians and patients.

Extension of deadline to submit new IPA affiliation

- ▶ Many PCPs advised IEHP that more time would be helpful to choose a new IPA affiliation to transfer Members assigned through Vantage Medical Group.
- ▶ The Department of Managed Healthcare (DMHC) originally required that we notify Members sixty (60) days in advance of the effective date of the Vantage termination, August 31, 2018.
- ▶ To give PCPs more time to select a new IPA, we requested a special waiver through DMHC to shorten the Member notice timeframe.
- ▶ DMHC has agreed to this request and we are extending the deadline to provide IEHP with written confirmation of your new IPA affiliation to:

July 20, 2018

- Concern over lack of choice; remaining IPAs
- ▶ Not business as usual. Concern over payment for specialty services next few month with current delays in claims payments

- ► Who do we get the data to? We have many 2017 unpaid claims with Vantage
- ▶ Are you open to contracting with a brand new physician owned and physician lead IPA?

- ▶ If your office has claims incurred within the last twenty-four (24) months that Vantage Medical Group has not processed within contractual or regulatory timeframes and were appealed to Vantage without satisfactory recourse, please contact IEHP Provider Relations team at (909) 890-2054. IEHP will review the specifics of the claim(s) to ensure that appropriate adjudication of the claims occurs.
- ▶ IEHP has always supported our physicians and made sure you are paid for services rendered to IEHP Members.

Things to consider when evaluating a contract:

- Review closely the term and termination clause
- Review wording on Exclusivity can you contract with more than one IPA or one IPA and a direct contract with IEHP if desired?
- ▶ Review the performance metrics closely
- Insure the specialists you refer to are part of the IPA's network
 - ▶ If you are unsure, IEHP can validate specialist contracts with specific IPAs
- ▶ Review the financial section, i.e. reimbursement.
 - Note: IEHP is undergoing a rate re-basing for both IPAs and IEHP-Direct more info will be available week of 6/18. Recommend you NOT sign a contract until the new rates for both IPAs and Directs are released to insure you have the latest information for consideration.
- ▶ When evaluating the financial section be sure to include base pmpm rates, P4P and additional income including Prop 56 (tobacco tax). Be sure these are included in the contract.
